You have violated the Constitution.


You have violated your own oath to uphold the Constitution. Your words and actions show that you spit upon your own oath. And you clearly demonstrate you are not fit to be a public servant.

As you do not have any form of jurisdiction over him, you are to hereby release Ambassador David immediately.

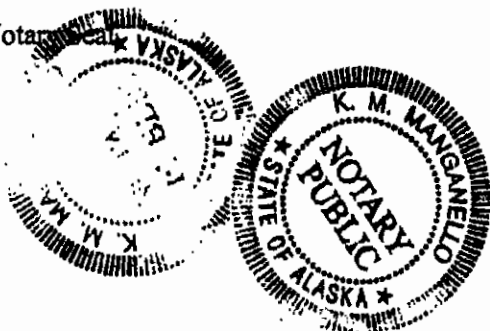

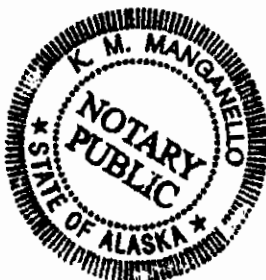
Instead, public servant Rasley refused, and has thus repeatedly violated Ambassador David and the Constitution.
